Listening and Learning – Family Road Trip Challenges

In my role as a summer intern for Cape Mediation, in training to provide technical support for remote mediations, I've attended some of Cape Mediation's recent online mediations. In these sessions, I've been impressed by the skill and tact of the mediators and coordinator in diffusing potential conflict and helping the parties effectively communicate to improve understanding and reach an agreement. What particularly stood out to me was the insight the volunteers gained from truly listening to each party. Rather than making any assumptions, they were careful to understand the particular interests of each side, and through this, empathize and authentically validate the emotions that arose. Continually, I've been in awe of how the Cape Mediation volunteers listened to the parties and each other –deeply and with intention– which, for their purpose, made them much more effective.

Recently, I went on a 14 hour road trip with my family, where I was graced with many opportunities to improve my own ability to listen deeply and with intention. As it turns out, being confined in a hot car with family members for a long period of time provides excellent practice for strengthening conflict management and communication skills.

While, when attending mediations as tech in-training, I was removed from the conflict, with my family, our sometimes-dysfunctional patterns of interaction are deeply ingrained and quite personal. In the car however, the practice of truly listening, which I observed during the mediations, proved just as effective and valuable.

When I found myself caught up in our squabbles or taking on stress from my sister or parents, I worked to take deep breaths to calm my own emotions and open myself up to non-judgmentally understanding their perspectives. Diffusing my personal frustration, I was able to actually hear where they were coming from, which inherently caused me to empathize and helped us come to agreement quicker and with fewer hurt feelings. Whether in a mediation session or a car with family, authentic listening opens space for understanding and collaboration. I'm grateful for the exposure to our skilled mediators at work and am looking forward to improving my own skills—in my personal life and beyond!

Daisy O'Neil will lead this in-person workshop on listening circles, providing context and history in the first part of class, then using the second half of the class to actively engage participants in a listening circle.

Listening circles rooted in restorative justice have a long and complex history of being used all over the world, stemming from Indigenous nations in North America and the Maori of New Zealand. They are used for rehabilitation after a conflict and place a huge emphasis on healing relationships and communities. Listening circles instill healthy communication, active listening, and validation, no matter what the topic!

We use listening circles in our Youth Program to facilitate productive conversations and teach important life skills, and want to open up this as an opportunity for others to experience them as well.

This event will be in-person at the Cape Mediation office, on Wednesday, July 30th, from 10-11:30 am, Space is limited so please RSVP ASAP.

Daisy is in the Spotlight This Month!

This month we are changing the scope of our Volunteer in the Spotlight Series to recognize Cape Mediation's year-round intern and Mediator, Daisy O'Neil. Thank you, Daisy for all of your handwork and dedication to Cape mediation.

Hi everyone! My name is Daisy, and I have been involved with Cape Mediation for over three years now. My journey began my junior year of high school, when some members of Cape Mediation came into a class I was taking at the time to teach us about the principles of mediation. Immediately, I realized I had no idea what mediation truly was! After a few classes, I realized it was something I was looking forward to every week, and I was learning skills that came very naturally to me. With the training I had received, eight students and I began Nauset Conflict Resolution in 2022, an after-school program that offered peer mediation as an alternative to administrative punishment. Students not referred to us by administration were also welcome to come take advantage of either mediation, listening circles, or one-on-one conflict coaching. This was one of the best and most fulfilling experiences I had in high school, as even though it was on a small scale we could really see the difference we were making in our community.

That same year, I began my internship with Cape Mediation's Youth Program Director, and together we worked with various schools across the Cape teaching our "Pathways to Peace" class. I will always be so grateful for my time with Cape Mediation while I was still in high school.

After my first year at university, I really missed being involved in this kind of work, so I immediately reached out to Cape Mediation to see how I could get involved again. I was so fortunate to have been rehired as a Youth Program intern, both in-person in the summers and remotely over the winter. Additionally, I had the opportunity to complete the Basic Mediation Training in 2024, and have completed the Advanced Practice Program. I love going into the courts, whether it is for mediations or to hear the call of the list; I just feel as though I learn so much from simply being there. I am excited to continue my journey as a mediator while strengthening my skills of creating programming for students!
